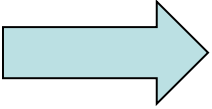


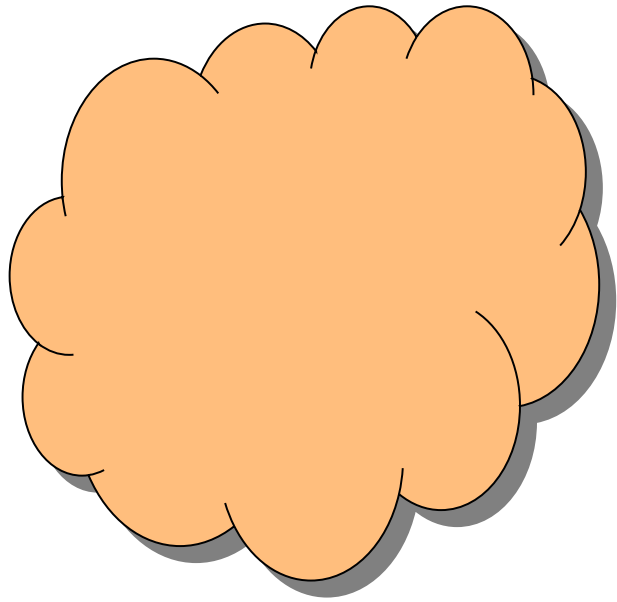
A Presumption of Equality

Justice means

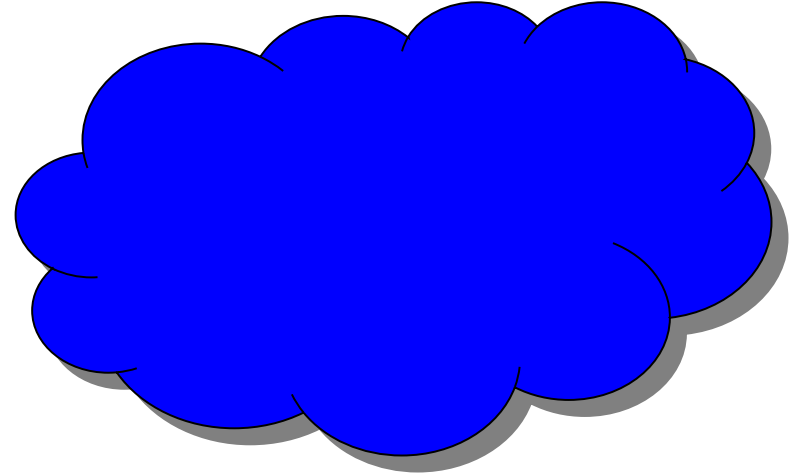
Like for Like

A relevant Difference

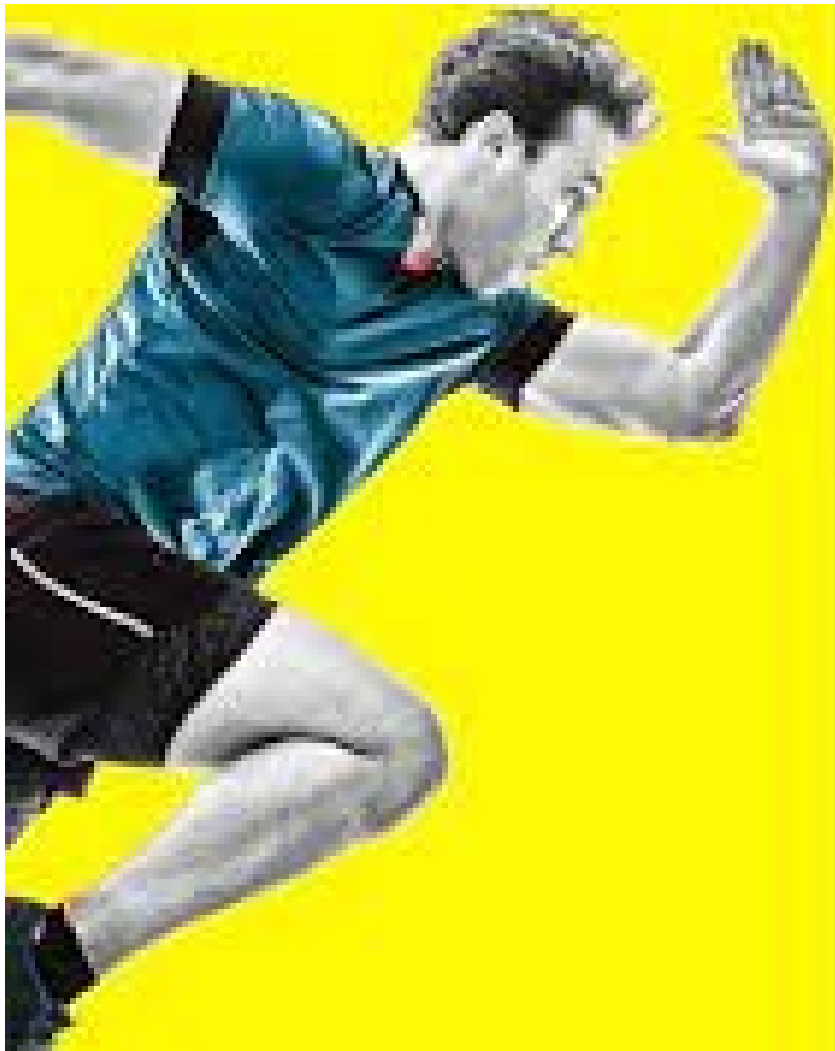
reasonably justifies

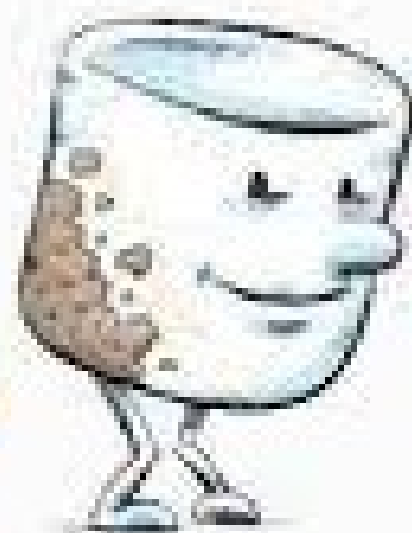
